Subject:- Request for taking steps for removal of song by Amrit Mann of Goniana, and his other similar videos from Youtube, in view of the directions issued by Hon'ble High Court.

Through E-mail/Speed Post

Sirs,

I am enclosing herewith a judgment rendered by the Hon'ble Punjab and Haryana High Court, Chandigarh in a bunch of Civil Writ Petitions, the main writ petition being CWP No. 6213 of 2016 (Reet Mohinder Singh Vs. State of Punjab and others) decided on 22.7.2019, as **Annexure-1** with the instant Application/ Complaint.

2. That the instant complaint is confined to the direction number (x) and direction (xv) contained in Para No. 28 of the aforesaid judgment. The said directions read as under:-

“x) The Director General of Police in the States of Punjab, Haryana and Union Territory, Chandigarh, are directed to ensure that no songs are played glorifying the liquor, wine, drugs and violence in any song even in live shows.”

“xv) The District Magistrates/ Senior Superintendents of Police/ Superintendents of Police of each district shall be personally responsible to ensure due compliance of the directions issued hereinabove.”

3. That I have come across a video recording of 2018-song of Karan Aujla, a Punjabi Singer which glorifies alcohol/liquor/wine. The entire song speaks volumes about liquor. Further, since the aforesaid singer is infamous, for such songs glorifying the liquor. Some of the lines from the said song are reproduced hereunder:-

“ਮੈਂ ਤੇ ਮੇਰੀ ਰਫਲ ਰਕਾਨੇ
ਕੋਮਬੀਨੇਸ਼ਨ ਚੋਟੀ ਦਾ
... ਵਰਗਾ ਨੇਚਰ ਜੱਟ ਦਾ
ਵੈਰੀ ਫੜ ਕੇ ਠੇਕੀ ਦਾ ”

A compact disc (CD) containing the aforesaid viral video is enclosed as **Annexure-2** with the instant Complaint. (Link of the Video is <https://youtu.be/ctJ4RiCRpH8>)

4. That the aforesaid video deserves to be removed from You Tube. I would therefore, call upon you to take up the matter with You Tube for removing this video. The particulars of the singer Amrit Mann, are as under:-

“Amrit Mann, village-Goniana: Mobile NO-8146089494”

I would therefore, call upon you to take appropriate steps for getting the aforesaid video removed from You Tube.

I would also call upon you to summon him, and get details of all or other videos which glorify liquor or violence, and to , and get all those videos removed from You Tube.

Needless to state that in case appropriate action is not taken qua the videos recorded by the aforesaid singer, within a period of one month from the date of receipt of this Demand Notice in your office (copies whereof are being sent through e-mail also to you, in that event, I shall be constrained to move appropriate proceedings under the Contempt of Courts Act before the Hon'ble High Court of Punjab and Haryana at Chandigarh for purported non-compliance by you with the aforesaid directions contained in the judgment,

Annexure-1, pronounced by the Hon'ble High Court on the above subject.
